Minutes

Roll Call: The meeting was called to order at 4:00 p.m. by Vice President Bob Murello. Those present: Bob Murello, vice president; Alyne Strusser, secretary; Jan Tenner, treasurer; Gail Weiss, social committee; Arlene Nemesek, membership; and Roman Petryszyn, equipment.

Minutes: The minutes of March 3, 2010 were approved as distributed.

Treasurer's Report: Jan Tenner presented the Treasurer's Report for the month of March. The beginning balance was \$2,692.10; dues collected were \$210; expenses were \$6.69 (Pat Carrell) leaving a balance of \$2,895.41.

New Business:
